TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of February 19, 2020 (“Release”), is made by Gordon Brothers Finance Company, in its capacity as agent pursuant to the Credit Agreement referred to below acting for and on behalf of the parties thereto as lenders and as otherwise provided therein (in such capacity, “Agent”), in favor of StorCentric, Inc., a Delaware corporation (“StorCentric”), Drobo, Inc., a Delaware corporation (“Drobo”, and together with StorCentric, the “Borrowers”), Nexsan Corporation, a Delaware corporation (“Nexsan”), Nexsan Technologies Incorporated, a Delaware corporation (“Nexsan Tech”), Connected Data, Inc., a California corporation (“Connected Data”), Nexsan Technologies Limited (“Nexsan Ltd”), Nexsan Technologies Canada Inc. (“Nexsan Canada”, and together with StorCentric, Drobo, Nexsan, Nexsan Tech, Connected Data, and Nexsan Ltd, collectively, the “Grantors”).

WITNESSETH:

WHEREAS, the Grantors are party to that certain Term Loan, Security and Guaranty Agreement dated as of August 16, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”) by and among the Borrowers, the other Grantors party thereto as Guarantors, the financial institutions which are now or which hereafter become a party thereto (collectively, the “Lenders” and each individually a “Lender”) and the Agent, pursuant to which Lenders, or Agent on behalf of Lenders, have agreed to make a term loan available to the Borrowers; and;

WHEREAS, the Grantors and Agent are parties to that certain Intellectual Property Security Agreement dated as of August 16, 2018, by and among the Grantors, 6360246 Canada Inc., 6360319 Canada Inc., and Agent (the “Intellectual Property Security Agreement”), that certain Short Form Intellectual Property Security Agreement dated as of August 16, 2018, by and among the Grantors and Agent (the “Short Form Intellectual Property Agreement”), and that certain Short Form Intellectual Property Security Agreement dated as of November 8, 2018, by and among StorCentric and Agent (the “StorCentric Short Form Intellectual Property Agreement”), and together with the Short Form Intellectual Property Security Agreement and the Intellectual Property Security Agreement, the “IP Security Agreements”).

WHEREAS, pursuant to the IP Security Agreements each Grantor has granted a continuing security interest in, and a general lien upon, and a conditional assignment of, the IP Collateral, including (a) the United States issued patents and pending patent applications shown on Schedule A (the “Patents”), notice of which was recorded pursuant to the Notice of Recordation of Assignment Document at the United States Patent and Trademark Office (“USPTO”) on August 17, 2018 at Reel 046845 Frame 0495, and (b) the United States registered trademarks and pending trademark applications shown on Schedule A (the “Trademarks”), notice of which was recorded pursuant to the Notices of Recordation of Assignment Document at the USPTO on August 16, 2018 at Reel 006416 Frame 0520 and November 8, 2018 at Reel 006578 Frame 0636.

WHEREAS, the Grantors have repaid all of their obligations; and

WHEREAS, the Agent now desires to terminate and release the entirety of its security interest in the IP Collateral, including the Patents and Trademarks granted pursuant to the IP Security Agreements.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, the parties) agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Intellectual Property Security Agreement, as applicable.

SECTION 2. Termination and Release. The Agent hereby:

(a) terminates, releases, and discharges its continuing security interest in and general lien upon, and any conditional collateral assignment of, the IP Collateral, including the Patents and Trademarks, granted pursuant to the IP Security Agreements without recourse, representation or warranty of any kind. Any and all right, title, or interest of Agent in the IP Collateral, including the Patents and Trademarks, granted pursuant to the IP Security Agreements and all products and proceeds thereof, are hereby reconveyed, transferred, and assigned to the entity entitled thereto, as applicable, without recourse, representation or warranty of any kind, and any right, title, or interest of Agent in the IP Collateral, including the Patents and Trademarks granted to the Agent pursuant to the IP Security Agreements shall hereby cease and become void;

(b) authorizes the recordation of this Release with the USPTO;

(c) agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release, provided that all such documents shall be prepared by Grantors' counsel and the cost and expense of such documents and actions shall be borne solely by the Grantors; and

(d) agrees that this Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Release by facsimile or other electronic means will be as effective as delivery of a manually executed counterpart of this Release.

This Release and the rights and obligations of the parties hereunder shall, in accordance with Section 5-1401 of the General Obligations Law of the State of New York, be governed by and construed and enforced in accordance with the laws of the State of New York.
