GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARK

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, Spark::red Inc. ("Grantor"), having its principal office at 11241 Willows Road, Suite 220, Building C Northeast, Redmond, WA 98052, hereby grants to Beedie Investments Ltd. ("Grantee") a security interest in (a) all of Grantor's right, title and interest in and to the United States trademark number 4325693 registered on April 23, 2013 and United States trademark number 4325694 registered on April 23, 2013 (the "Marks"), (b) all proceeds and products of the Marks, (c) the goodwill of the businesses with which the Marks is associated and (d) all causes of action arising prior to or after the date hereof for infringement of the Marks or unfair competition regarding the same.

This Grant is made to secure the satisfactory performance and payment of the Obligations, as such term is defined in that certain credit agreement dated as of February 14, 2020 (as amended, restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), by and among Reliant Web Hosting Inc. and Grantee. Upon termination of the Credit Agreement, Grantee shall execute, acknowledge and deliver to Grantor, upon Grantor's request and at Grantor's expense, an instrument in writing releasing the security interest in the Marks acquired under this Grant.

This Grant has been granted in conjunction with the security interest granted to Grantee under the general security agreement dated as of the date hereof by and among Grantor and Grantee (the "Security Agreement"). The rights and remedies of Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

This Grant and any amendments hereto may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which counterparts taken together shall constitute but one and the same instrument. Any amendment hereto shall require the written agreement of Grantor and Grantee. Counterparts of this Grant may be delivered by facsimile or electronic mail and the effectiveness of this Grant and signatures hereon shall have the same force and effect as manually signed originals.
