**DECLARATION IN SUPPORT OF CORRECTIVE ASSIGNMENT**

Registrant, Hartz Franchise Restaurants, Ltd. (“Registrant”) seeks correction of the U.S. Patent & Trademark Office (USPTO) interpretation of a name change document recorded on 11/25/2019 at Reel/Frame: 6804/0032 regarding the nine above-listed registrations (also listed in Exhibit A annexed hereto). A copy of the Cover Sheet of such recordation is also filed herewith.

Registrant is presently and has always been the Registrant and owner of the nine above-listed registrations (also listed in Exhibit A annexed hereto). These nine registrations issued in the name of Registrant Hartz Franchise Restaurants, Ltd., a Texas Limited Partnership having as its General Partner, V.N. Ventures, LLC, a Texas Limited Liability Company. By virtue of the Articles of Amendment to the Articles of Organization of V.N. Ventures, LLC (filed with the Texas Secretary of State’s Office on 3/11/2005), V.N. Ventures, LLC changed its name to Hartz Chicken, LLC.

To update the nine above-referenced registrations to reflect the current name of Registrant’s General Partner, the undersigned attorney of record for Registrant recorded with the USPTO the above-referenced Articles of Amendment to the Articles of Organization of V.N. Ventures, LLC on 11/25/2019 at Reel/Frame: 6804/0032. At the time of the recordation using the USPTO’s online recordation (ETAS) system, the undersigned believed that checking the “Change of Name” button under “Conveyance Type” was the only applicable and accurate characterization of the document being recorded. However, as a result of the recordation of this name change document, rather than updating the General Partner’s name, the USPTO records now indicate that the General Partner, Hartz Chicken, LLC is the new owner of record of these nine registrations. This is an error in fact that requires correction. The document that was recorded at Reel/Frame: 6804/0032 merely reflects the change of name of Registrant’s General Partner from V.N. Ventures, LLC to Hartz Chicken, LLC. It did not convey any ownership rights or title in the registrations from Registrant to Hartz Chicken, LLC.

Therefore, Registrant respectfully requests that the USPTO assignment records be corrected to reflect that the owner of the nine above-referenced U.S. Trademark Registrations is Hartz Franchise Restaurants, Ltd., a Texas Limited Partnership having as its General Partner, Hartz Chicken, LLC, a Texas Limited Liability Company. It is the undersigned’s understanding from a telephone conversation with USPTO Assignment Branch personnel on 2/20/2020, that a Corrective Assignment must be filed.

The undersigned respectfully requests a waiver or refund of the recordation fees for this instant filing as it is Registrant's position that the original filing was correctly designated in the USPTO's ETAS system, but that the information extracted was inadvertently misapplied by the USPTO's ETAS system requiring this corrective assignment filing.

Pursuant to the provisions of Article 3.06 of the Texas Limited Liability Company Act, the undersigned, V.N. Ventures, LLC, a Texas limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization.

**ARTICLE ONE**

The name of the Corporation is V.N. Ventures, LLC. The filing number issued to the Company by the Texas Secretary of State is 800351285.

**ARTICLE TWO**

The amendment changes the Articles of Organization to change the article that names the limited liability company. That article in the Articles of Organization is amended to read as follows:

"ARTICLE 1. - Name

That Article 1 of the Articles of Organization be amended by deleting the present Article 1 and by inserting in lieu thereof the following:

"The name of the limited liability company is Hartz Chicken, LLC."

**ARTICLE THREE**

The date of the approval of the amendment is March 11, 2005.



**ARTICLE FOUR**


