**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "*Termination and Release*") is granted as of February 18, 2020 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, in its capacity as administrative and collateral agent (in such capacity, together with its successors and permitted assigns the "*Lender*"), in favor of **PARLUX HOLDINGS, INC.** (formerly known as Perfumania Holdings, Inc.), a Florida corporation (together with its successor and assigns the "*Grantor*").

WHEREAS, pursuant to the Grant of Security Interest and the Amended and Restated Grant of Security Interest in United States Trademarks, each dated as of October 11, 2017 (together, the "Assignment of Trademark Rights"), Grantor granted Lender a security interest in all of the Trademark Collateral (as defined in the Assignment of Trademark Rights).

WHEREAS, Grantor has requested and Lender has agreed to provide this Termination and Release to confirm the release, relinquishment and discharge of Lender's security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Lender hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Assignment of Trademark Rights.

2. Release of Security Interest. Lender hereby terminates, releases, relinquishes and discharges its security interest and liens in the Trademark Collateral, including without limitation, in the Grantor's right, title and interest in and to each trademark and trademark license listed on Schedule 1 hereto, and all goodwill associated therewith, as well as any other lien or security interest it may have in the Trademark Collateral or any other collateral of Grantor under the Assignment of Trademark Rights, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind.

3. Authorization. Lender hereby authorizes Grantor or Grantor's agent to record this Termination and Release with the United States Patent and Trademark Office and any foreign trademark office as required.
