TRADEMARK ASSIGNMENT

This Trademark Assignment is made effective as of January 1, 2020 by and between **Metso Minerals Industries, Inc.**, a corporation registered in Delaware ("Metso Minerals") and **Neles USA Inc.**, a corporation organized and registered in Delaware ("Neles). In consideration of the premises, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Metso Minerals Industries, Inc. hereby sells, assigns, transfers and sets over to Neles USA Inc. the entire right, title and interest in and to the trademarks (a) PLANTTRIAGE and (b) EXPERTUNE (collectively "the Trademarks"), together with the goodwill associated with the Trademarks, for the United States and for all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, including those matters identified on the attached **Schedule 1**.
2. Metso Minerals represents and warrants that: (i) it is the sole and exclusive owner of the entire right, title and interest in and to the Trademarks (including the corresponding rights set forth in the above), free and clear of any liens, security interests or other encumbrances; (ii) it has the full right and authority to execute this Assignment and to assign to Neles the rights assigned herein; and (iii) it has not executed, and will not execute, any agreement or other instrument in conflict herewith;
3. Metso Minerals shall take all further actions, and provide to Neles' successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) reasonably requested by Neles to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution of any application for registration, or any application for renewal of a registration, relating to any of the rights assigned herein; (2) the prosecution or defense of any interference, opposition, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, without limitation, testifying as to any facts relating to the Trademarks and this Assignment; (3) obtaining any additional trademark protection relating to rights assigned herein that Assignee reasonably may deem appropriate that may be secured under the laws now

or hereafter in effect in the United States or in any foreign country; and (4) in the implementation or perfection of this Assignment in all applicable jurisdictions throughout the world.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Metso Minerals does hereby sell, assign and transfer to Neles all rights, title and interest in and to the Trademarks, together with the good will of the business symbolized by the Trademarks, and the identified registrations thereof.
