ARTICLES OF CONVERSION

OF

SMARTRONIX, INC.

FROM A CORPORATION TO A LIMITED LIABILITY COMPANY

Smartronix, Inc., a Maryland corporation (the "Corporation"), hereby files these articles of conversion (these "Articles") with the Maryland State Department of Assessments and Taxation ("SDAT") for the purposes of converting from a corporation to a limited liability company under Section 3-901 of the Maryland General Corporation Law (the "MGCL") and Section 4A-1101 of the Maryland Limited Liability Company Act (the "Act") and certifies:

FIRST: The name of the Corporation immediately prior to the filing of these Articles is Smartronix, Inc. The Corporation is a Maryland corporation formed by the filing of Articles of Incorporation on March 20, 1995.

SECOND: By virtue of these Articles and the Articles of Organization filed for record contemporaneously herewith, the Corporation is converting into Smartronix, LLC, a limited liability company organized in the State of Maryland under and pursuant to the MGCL and the Act (the "Company").

THIRD: Upon the completion of the conversion in accordance with the MGCL and the Act, the Company shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Corporation.

FOURTH: The conversion has been approved in accordance with Section 3-902 of the MGCL.

FIFTH: The manner and basis of converting outstanding shares of stock of the Corporation into membership interests of the Company is as follows: each outstanding share of stock in the Corporation, \$10.00 par value per share, will be immediately converted into one outstanding membership interest in the Company, the aggregate of which membership interests will represent 100% of the membership interests in the Company.

SIXTH: The conversion is effective as of the acceptance for record of these Articles by the SDAT.

ARTICLES OF ORGANIZATION

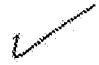

The undersigned, Aileen Collender, whose post office address is 100 Light Street, Baltimore, MD 21202, being at least 18 years of age and duly authorized to execute and file these Articles of Organization, hereby forms a limited liability company under the Maryland Limited Liability Company Act (the "Act") and certifies to the State Department of Assessments and Taxation of the State of Maryland (the "SDAT") as follows:

1. Conversion from Maryland Corporation. Pursuant to Section 3-901 of the Maryland General Corporation Law and the provisions of the Act, these Articles of Organization are being filed with the SDAT contemporaneously with Articles of Conversion converting Smartronix, Inc., a Maryland corporation (the "Converting Corporation"), to Smartronix, LLC, a Maryland limited liability company (the "Company"). Upon the completion of the conversion in accordance with the Maryland General Corporation Law and the Act, the Company shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Converting Corporation.

2. Name of the Company. The name of the limited liability company (hereinafter referred to as the (the "Company")) is: Smartronix, LLC. 

3. Principal Office. The principal office of the Company is 44150 Smartronix Way, Hollywood, MD 20636. 

4. Resident Agent. The resident agent of the Company is CSC - Lawyers Incorporating Service Company, 7 St. Paul Street, Suite 820, Baltimore, MD 21202. The resident agent of the Company named herein is a Maryland resident. 

5. Existence. The Company shall have a perpetual existence.

6. Limitation of Authority of Members. Pursuant to Section 4A-401(a)(3) of the Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to act for the Company solely by virtue of being a member.

7. Effective Date. These Articles of Organization shall be effective as of the date of their acceptance for filing by the State Department of Assessments and Taxation of the State of Maryland.
