TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, subject to the Retained Right, which shall remain the sole and exclusive right owned by ASSIGNOR, ASSIGNOR does hereby assign and transfer to ASSIGNEE, all right, title and interest in and to only the Assigned Registrations, together with the goodwill associated therewith, and including all income, royalties, and damages due or accrued on or after the date of this Assignment hereafter due and payable to such ASSIGNOR with respect to the Assigned Registrations, including without limitation, damages for any and all present and future causes of action and other enforcement actions (including, without limitation, for injunctive remedies and relief) and future rights to damages and profits, due or accrued, relating to any of the foregoing, including the right to sue and recover for, and the right to profits and damages, due or accrued, arising out of or in connection with, any and all present or future infringements, misappropriations or dilutions; all rights pursuant to 15 U.S.C. 1051 et. seq., and

all other applicable acts and associated amendments; and all rights regarding the Assigned Registrations that apply in any country relating to any foreign counterpart, certification, registration or other governmental grant or issuance relating to, or seeking the benefit of, the Assigned Registrations throughout the world and including the right to further transfer and assign the Assigned Registrations without further remuneration or consideration to ASSIGNOR.

Notwithstanding anything to the contrary herein, (i) other than the Assigned Registrations, this Assignment does not apply to any other trademarks or names owned or used by ASSIGNOR, and (ii) ASSIGNOR shall be, at all times, sole and exclusive owner of, and shall retain, all rights to the following related to the Assigned Registrations: all income, royalties, and damages due or accrued prior to the date of this Agreement, including, without limitation, the right to sue for and recover damages for any and all past causes of action (collectively, the "Retained Right").


This Assignment shall be binding upon and shall inure to the benefit of the parties and their respective officers, affiliates, personal and legal representatives, heirs, successors and assigns.


