**TERMINATION AND RELEASE OF NOTICE OF GRANT OF A SECURITY INTEREST -
TRADEMARKS**

THIS TERMINATION AND RELEASE OF NOTICE OF GRANT OF A SECURITY INTEREST- TRADEMARKS (this "Termination"), is dated as of February 18, 2020, and made by VIRTUS GROUP, LP ("Grantee") in its capacity as agent under the below-defined Security Agreement, to LAPOLLA INDUSTRIES, INC., a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of November 30, 2017 (the "Security Agreement"), made by the Grantor and the other Loan Parties party thereto in favor of Grantee, a security interest was granted by the Grantor to Grantee, in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, to record the security interest granted under the Security Agreement, a Notice of Grant of a Security Interest – Trademarks ("Trademark Security Agreement"), dated as of November 30, 2017, was recorded in the Trademark Division of the United States Patent and Trademark Office (the "USPTO") on December 1, 2017, at Reel 6217 and Frame 0550;

WHEREAS, Grantee now desires to terminate and release its security interest in the Trademark Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, means the Grantor's Trademarks (as such term is defined in the Security Agreement), other than any "intent-to-use" applications for registration of a trademark, together with, among other things, the goodwill of the business symbolized by Trademarks owned by the Grantor, and including those trademarks set forth on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates, releases and discharges all of its security interests and liens in, to and under the Trademark Collateral. Grantee acknowledges that this Termination may be filed with the United States Patent and Trademark Office or any other governmental office to evidence the partial termination and release granted by this Termination.

3. Choice of Law. This Termination shall be governed by and construed in accordance with the laws of the State of New York.

4. Further Assurances. Grantee agrees to take all further actions, and provide to each applicable Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.
