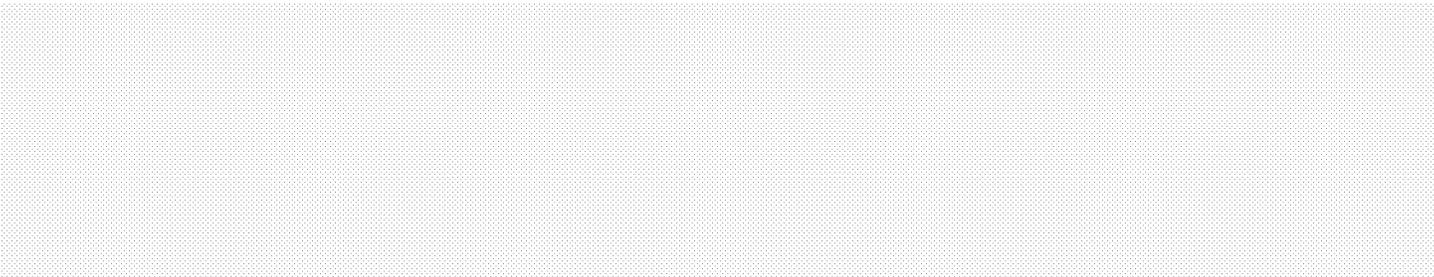
Pursuant to Title 8, Section 252 of the Delaware General Corporation Law:
