TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENTS (this "Termination"), is dated as of February 24, 2020, and made by **CITIZENS BANK, N.A.**, (as Successor by Merger to Citizens Bank of Pennsylvania), as Administrative Agent (the "Grantee"), to **CONSOLIDATED AEROSPACE MANUFACTURING, LLC**, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of March 27, 2014 by the Grantor in favor of the Grantee (the "Initial Security Agreement") and, was recorded at the United States Patent and Trademark Office on March 28, 2014 as Document Number 900284365 at Reel/Frame 5245/0972, a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks dated as of August 11, 2015 by the Grantor in favor of the Grantee (the "Amended and Restated Security Agreement" and together with the Initial Security Agreement, collectively known as the "Security Agreements") and, was recorded at the United States Patent and Trademark Office on August 14, 2015 as Document Number 900334363 at Reel/Frame 5599/0539, a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, Grantee now desires to terminate and release the Security Agreements;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral" as used herein, shall have the meaning set forth in the Security Agreements, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreements and terminates, releases and discharges its lien on and security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.


