TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of February 24, 2020, and made by **CITIZENS BANK, N.A.**, (as Successor by Merger to Citizens Bank of Pennsylvania), as Administrative Agent (the "Grantee"), to **MOELLER MANUFACTURING & SUPPLY, LLC**, a California limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademark dated as of April 13, 2018 by the Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on April 13, 2018 as Document Number 900446728 at Reel/Frame 6313/0245; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Trademark Collateral" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its lien on and security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
