WHEREAS, ASSIGNEE desires to acquire the entire right, title and interest in and to the TRADEMARKS of ASSIGNOR, together with the goodwill of the business symbolized thereby;

NOW, THEREFORE, for consideration of one dollar (\$1.00) and other good and valuable consideration paid by ASSIGNEE to ASSIGNOR, the receipt and sufficiency of which hereby is acknowledged, ASSIGNOR does hereby sell, assign and transfer to ASSIGNEE ASSIGNOR's entire right, title and interest in and to the TRADEMARKS, together with the goodwill of the business symbolized thereby, and any and all other rights and interests arising out of, in connection with or in relation to the TRADEMARKS, said TRADEMARKS to be held and enjoyed by the ASSIGNEE, its successors and assigns as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this assignment not been made, including all rights therein provided by international conventions and treaties, and all causes of action, including all rights of recovery for past, present and future infringement thereof.

FURTHER, ASSIGNOR hereby covenants and agrees to execute and deliver, at the request of ASSIGNEE, such further instruments of transfer and confirmatory assignment in recordable form and to take any other lawful action as such ASSIGNEE may reasonably request to more effectively consummate the assignments contemplated by this Assignment. Specifically, ASSIGNOR agrees to, upon the request and at ASSIGNEE's expense, execute, acknowledge and deliver such further documents, instruments, conveyances and assurances and take such further actions as may be reasonably required to register and/or to vest record title of said respective registrations in the name of ASSIGNEE the assignment of any of the TRADEMARKS herein assigned in any appropriate governmental agency or registrar.

This Assignment may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, and all counterparts together shall constitute a single agreement.


