## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "*Trademark Assignment*"), dated as of January 22, 2020, is made by Columbian Home Products, LLC, an Illinois limited liability company located at 404 N. Rand Road, Barrington, IL 60010 (the "*Seller*"), in favor of Honey-Can-Do International, LLC, an Illinois limited liability company located at 5300 St. Charles Road, Berkeley, IL 60163 (the "*Buyer*"), the purchaser of certain assets of the Seller pursuant to the Purchase Agreement dated as of the date hereof among the Seller and Delvin Ryan Jr., on the one hand, and the Buyer on the other hand (the "*Purchase Agreement*").

### Preliminary Statements

Under the terms of the Purchase Agreement, the Seller has conveyed, transferred, and assigned to the Buyer, among other assets, certain intellectual property of the Seller, and has agreed to execute and deliver this Trademark Assignment for recording with the United States Patent and Trademark Office.

### Assignment

For good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Seller and the Buyer agree as follows.

1. Assignment. The Seller hereby irrevocably conveys, transfers, and assigns to the Buyer all of Seller's entire right, title, and interest in and to the following:

(a) the trademark registrations set forth on Schedule 1 hereto and all issuances, extensions, and renewals thereof (the "*Assigned Trademarks*"), together with the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks;

(b) all rights of any kind whatsoever of Seller accruing under any of the foregoing as of and after the date hereof provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world;

(c) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(d) any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

For the avoidance of doubt, nothing herein shall be deemed to affect or limit the obligations of the Buyer or the rights of the Seller under the Royalty Agreement between the Seller and the Buyer of even date herewith (the "*Royalty Agreement*") with respect to the Royalty (as defined in the Royalty Agreement) payments due thereunder.

2. Recordation and Further Actions. The Seller hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon the Buyer's request.

3. Terms of the Purchase Agreement. The parties hereto acknowledge and agree that this Trademark Assignment is entered into pursuant to the Purchase Agreement, to which reference is made for a further statement of the rights and obligations of the Seller and the Buyer with respect to the Assigned Trademarks. The representations, warranties, covenants, agreements, and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

4. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed one and the same agreement. A signed copy of this Trademark Assignment delivered by means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.

5. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

6. Governing Law. This Trademark Assignment and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Trademark Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Illinois, without giving effect to any choice or conflict of law provision or rule (whether of the State of Illinois or any other jurisdiction).






