- (3) United States Trademark Application No. 78552968 for the mark EDDIE WOULD GO in classes 9, 16 and 25, filed January 24, 2005, in the name of Assignor;
- (4) Any and all goodwill associated therewith;
- (5) Any and all causes of action for infringement of and/or misappropriation of and/or unfair competition concerning the assigned rights, past, present, and future, and all of the proceeds from the foregoing accrued and unpaid and hereafter accrued.

This assignment is made without representations or warranty of any kind except that Assignor represents to Assignee that it knows of no parties claiming rights in the assigned marks apart from Assignee and its members.
