TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT (this “**Trademark Security Agreement**”) dated as of February 26, 2020 is made by **CHURCH COMMUNITY BUILDER, LLC** (the “**Grantor**”) in favor of **BANK OF NEW ZEALAND**, as agent (the “**Agent**”) . Terms used and not otherwise defined herein shall have the meaning set forth in the Security Agreement (as defined below).

WHEREAS, the Grantor has entered into that certain Syndicated Facility Agreement, dated as of December 12, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Facility Agreement**”), pursuant to that certain Accession Letter dated as of December 12, 2019, with the Agent and the other parties thereto;

WHEREAS, pursuant to the Facility Agreement, the Grantor has executed and delivered that certain Security Agreement, dated as of December 12, 2019, made by the Grantor and the other grantors thereunder to the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”); and

WHEREAS, under the terms of the Security Agreement, the Grantor has granted to the Agent, for the benefit of the Beneficiaries, a security interest in, among other property, certain intellectual property of the Grantor, and has agreed pursuant to the Security Agreement and the Facility Agreement to execute this Trademark Security Agreement for recording with the U.S. Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees as follows:

SECTION 1. Grant of Security. The Grantor hereby grants to the Agent for the benefit of the Beneficiaries a security interest in the Grantor’s right, title and interest in its trademark registrations, including those set forth on Schedule I hereto and the goodwill associated therewith, and all proceeds thereof, whether now owned or existing or hereafter acquired, possessed or arising and wherever located, in each case, excluding any Excluded Assets (collectively, the “**Trademark Collateral**”).

SECTION 2. Security Agreement. The grant of a security interest in the Trademark Collateral by the Grantor under this Trademark Security Agreement is granted in conjunction with the security interests granted to the Agent pursuant to the Security Agreement and is subject to the terms and limitations set forth therein and in the Facility Agreement. The Grantor hereby acknowledges and affirms that the rights and remedies of the Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.

SECTION 3. Recordation. The Grantor authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office and any other applicable government officer record this Trademark Security Agreement.

SECTION 4. Execution in Counterparts. This Trademark Security Agreement shall be executed in counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Trademark Security Agreement. Delivery of an executed counterpart of a signature page of this Trademark Security Agreement by facsimile or in electronic (e.g., “pdf” or “tif”) format shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement.

SECTION 5. Governing Law. This Trademark Security Agreement shall be governed by, and construed in accordance with, the laws of the State of New York.






