Whereas:

- The Assignor is the rightful owner of the United States trademarks and trademarks applications identified in the schedules attached hereto and made a part hereof (hereinafter collectively "the IP Rights") together with the goodwill that has accrued.
- The Assignor and the Assignee agree that the IP Rights shall be sold, assigned, transferred and conveyed from the Assignor to the Assignee upon the terms hereinafter contained.
- The Assignor and the Assignee agree that this assignment be duly recorded before the relevant intellectual and/or Industrial Property Office as required to protect the acquired rights and obligations, and by the Assignee alone where the laws of the jurisdiction before which the present assignment is to be recorded allow so.

- The Assignor hereby covenants with the Assignee that the Assignor will, at the expense of the Assignee, execute, sign and do all such instruments, applications, documents, acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned.
- The Assignee hereby accepts this assignment with all the rights, privileges and obligations as pertaining thereto.
- The person signing this document on behalf of the Assignor expressly declares to be duly empowered to execute documents on behalf of the Assignor and alienate assets of the Assignor.
- The person signing this document on behalf of the Assignee expressly declares to be duly empowered to represent the Assignee.

- Should the laws of the jurisdiction before which the present assignment is to be recorded allow so, this Assignment may be executed in counterparts, each of which will be an original as regards any party whose signature appears thereon and all of which together will constitute one and the same instrument.
