INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as it may be amended, restated, supplemented or otherwise modified from time to time, this **Agreement**) is entered into as of February 28, 2020 among each of the undersigned (including each of their successors and permitted assigns, collectively the **Grantors** and each a **Grantor**), and Bridging Finance Inc., as agent and lender (the **Agent**).

W I T N E S S E T H:

WHEREAS, pursuant to a Canadian Security Agreement and the US Pledge and Security Agreement both dated as of the date hereof (as such agreements may be amended, amended and restated, supplemented or otherwise modified from time to time, collectively the "**Security Agreements**"), between, among others, the Grantors and the Agent, the Grantors have granted to the Agent a security interest in substantially all of the Grantors' personal property, including, without limitation, the Collateral referred to in Section 1 below; and

WHEREAS, each of the Grantors has agreed to execute this Agreement in respect of its Collateral for recording with the Canadian Intellectual Property Office, the United States Patent and Trademark Office, and any other office in which a security interest in the Collateral may be recorded under the laws of any other applicable jurisdiction;

NOW, THEREFORE, in consideration of the premises and the mutual covenants and agreements hereinafter set forth, the Grantors and the Agent agree as follows:

1. Grant of Security. Each Grantor hereby grants to the Agent a security interest in and to all of such Grantor's right, title and interest in and to all Patents, Trademarks, and Copyrights, as defined below (collectively, the "Collateral"):

(a) all present and future right, title, and interest in and to: (a) any and all patents and patent applications; (b) all inventions and improvements described and claimed therein; (c) all reissues, divisions, continuations, renewals, extensions, and continuations-in-part thereof; (d) all income, royalties, damages, claims, and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages and payments for past and future infringements thereof; (e) all rights to sue for past, present, and future infringements thereof; and (f) all rights corresponding to any of the foregoing throughout the world, including, but not limited to, the patents set forth in Schedule A hereto, as Schedule A may be supplemented from time to time by supplements to this Agreement which may be executed and delivered by the Grantors to the Agent from time to time (the "Patents");

(b) all present and future right, title, and interest in and to the following: (a) all trademarks (including service marks), trade names, trade dress, and trade styles and the registrations and applications for registration thereof and the goodwill of the business symbolized by the foregoing; (b) all licenses of the foregoing, whether as licensee or licensor; (c) all renewals of the foregoing; (d) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof; (e) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (f) all rights corresponding to any of the foregoing throughout the world, including, but not limited to, the trademark and service mark registrations, applications, and licenses set forth in Schedule B hereto, as Schedule B may be supplemented from time to time by supplements to this Agreement which may be executed and delivered by the Grantors to the Agent from time to time (the "Trademarks"); and

(c) all present and future right, title, and interest in and to the following: (a) all copyrights, rights and interests in copyrights, works protectable by copyright, copyright registrations, and copyright applications; (b) all renewals of any of the foregoing; (c) all income, royalties, damages, and payments now or hereafter due and/or payable under any of the foregoing, including, without limitation, damages or

payments for past or future infringements for any of the foregoing; (d) the right to sue for past, present, and future infringements of any of the foregoing; and (e) all rights corresponding to any of the foregoing throughout the world, including, without limitation, the registrations and applications and copyright licenses set forth in Schedule C hereto, as Schedule C may be supplemented from time to time by supplements to this Agreement which may be executed and delivered by the Grantors to the Agent from time to time (the "Copyrights").

2. Excluded Trademark Collateral. For the avoidance of doubt, in no event shall the "Trademarks" as defined above include a grant of security interest in any intent-to-use trademark applications (and rights in and to such applications) filed in the United States Patent and Trademark Office, pursuant to Section 1(b) of the Lanham Act, 15 U.S.C Section 1051 (the "Lanham Act") prior to the accepted filing of a "Statement of Use" or "Amendment to Allege Use" and issuance of a "Certificate of Registration" pursuant to Section 1(d) of the Lanham Act, whereby such intent-to-use trademark application is amended to conform to the requirements for a "use in commerce" application pursuant to Section 1(c) of the Lanham Act, to the extent that granting a security interest in such trademark application prior to such filing and acceptance would adversely affect the enforceability or validity of such trademark registration or this Agreement. The foregoing grant is merely a grant of a security interest and shall not be deemed an assignment.

3. Security for Obligations. This Agreement secures, and the Collateral is collateral security for the prompt and complete payment and performance of all Obligations (as such term is defined in both of the Security Agreements).

4. Recordation. Each Grantor authorizes that this Agreement be recorded at the Canadian Intellectual Property Office, the United States Patent and Trademark Office, and any other office in which a security interest in the Collateral may be recorded under the laws of any other applicable jurisdiction.

5. Execution in Counterparts. This Agreement may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

6. Grants, Rights and Remedies. This Agreement has been entered into in conjunction with the provisions of the Security Agreements. The Grantors hereby acknowledge and confirm that the grant of the security interest hereunder to, and the rights and remedies of, the Agent with respect to the Collateral are more fully set forth in the Security Agreements, the terms and provisions of which are incorporated herein by reference as if fully set forth herein.

7. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the Province of Ontario and the laws of Canada applicable therein, without regard to conflict of laws principles.

8. Counterparts and Electronic Delivery. This Agreement may be executed in any number of separate counterparts and all such signed counterparts constitute one and the same agreement. Delivery by facsimile or other electronic means of an originally executed signature page to this security agreement by a party is as effective as personal delivery of such signature page.




