INTELLECTUAL PROPERTY SECURITY AGREEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT (as amended, restated, supplemented or otherwise modified from time to time, the "Agreement") is entered into as of February 28, 2020, by and between HERCULES CAPITAL, INC., a Maryland corporation ("Agent") and APPSMART CCC, INC., a California corporation and APPSMART TGN, INC., a Delaware Corporation (collectively "Grantors", and each, a "Grantor").

RECITALS

A. Lender has agreed to make certain advances of money and to extend certain financial accommodation (the "Loans") pursuant to that certain Loan and Security Agreement, dated as of December 29, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and among APPDIRECT, INC., a Delaware corporation and certain of its subsidiaries party thereto as borrowers, the several banks and other financial institutions from time to time parties thereto as lenders (individually or collectively, as the context may require, "Lender"), and Agent.

B. On or about the date hereof, Grantors each are entering into a Joinder Agreement to become a borrower pursuant to the Loan Agreement.

C. Pursuant to the Loan Agreement, each Grantor is required to enter into this Agreement to further evidence the grant to Agent of the security interest in its Copyrights, Trademarks and Patents to secure the Secured Obligations.

AGREEMENT

NOW, THEREFORE, each Grantor agrees as follows:

1. To secure the Secured Obligations and any other obligations pursuant to the Loan Documents, each Grantor grants and pledges to Agent a security interest in all of such Grantor's Intellectual Property (including without limitation those Copyrights, Patents and Trademarks registered with the United States Patent and Trademark Office and the United States Copyright Office, a complete list of which is set forth on Exhibits A, B and C hereto, respectively).

2. This security interest is granted in conjunction with the security interest granted to Agent under the Loan Agreement. The rights and remedies of Agent with respect to the security interest are as set forth in the Loan Agreement and the other Loan Documents or as are now or hereafter available to Agent as a matter of law or equity, shall be cumulative and concurrent.

3. Each Grantor represents and warrants that Exhibits A, B, and C attached hereto set forth any and all Copyrights, Patents and Trademarks in connection with which such Grantor has registered or filed an application with the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

4. Each Grantor hereby authorizes Agent to (a) modify this Agreement unilaterally by amending the exhibits to this Agreement to include any Intellectual Property which such Grantor obtains subsequent to the date of this Agreement, and (b) file a duplicate original of this Agreement containing amended exhibits reflecting such new Intellectual Property with the United States Patent and Trademark Office or the United States Copyright Office, as applicable.

5. All capitalized terms used herein without definition shall have the meanings ascribed thereto in the Loan Agreement.


