## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of February 26, 2020, by Antares Capital LP, in its capacity as Administrative Agent ("Agent") in favor of Liqui-Box Corporation, an Ohio corporation ("Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreements (as defined below).

### WITNESSETH:

WHEREAS, Grantor and Agent are party to (i) that certain Trademark Security Agreement dated as of October 1, 2015, which was recorded by the Trademark Division of the United States Patent and Trademark Office on October 5, 2015 at Reel 5638, Frame 0027 (the "2015 Security Agreement"); (ii) that certain Trademark Security Agreement dated as of January 11, 2018, which was recorded by the Trademark Division of the United States Patent and Trademark Office on January 16, 2018 at Reel 6250, Frame 0097 (the "2018 Security Agreement") ; and (iii) that certain Trademark Security Agreement dated as of September 20, 2019, which was recorded by the Trademark Division of the United States Patent and Trademark Office on September 24, 2019 at Reel 6752, Frame 0988, (the "2019 Security Agreement" and together with the 2015 Security Agreement and the 2018 Security Agreement, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements Grantor has granted a security interest in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent as administrative agent, including the Trademark Collateral set forth on Schedule A annexed hereto;

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases and terminates its Lien on and security interest in all of Grantor's right, title and interest in, to and under the following Collateral of Grantor (collectively, the "Trademark Collateral");

(i) all of its Trademarks, including, without limitation, the Trademarks referred to on Schedule A;

(ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and


(iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Trademarks and the Trademark Collateral.




