

RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated February 28, 2020 (the “*Release*”) by BMO Harris Bank N.A., a national banking association, with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (“*BMO Harris*”), acting as administrative agent under the Agreement (as defined below) for the Secured Creditors as defined in the Agreement (as defined below) (BMO Harris acting in its capacity as administrative agent shall be hereinafter referred to as the “*Agent*”);

WITNESSETH:
