RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of February 2, 2020 ("Effective Date") by and Silicon Valley Bank, a California corporation ("Grantee"), and 3Pillar Global, Inc., a Virginia corporation, with its principal office at 3975 Fair Ridge Drive, Suite 200, Fairfax, Virginia 22022 ("Grantor").

WHEREAS, pursuant to the terms and conditions of the Intellectual Property Security Agreement dated November 29, 2011, the Amended and Restated Intellectual Property Security Agreement dated October 28, 2013, the First Supplement to the Intellectual Property Security Agreement dated June 30, 2015, and the Second Amended and Restated Intellectual Property Security Agreement dated December 24, 2015 (collectively, the "Trademark Security Agreements") by and between Grantor and Grantee, Grantor granted to Grantee a security interest in and to, among other things, all of Grantor's right, title and interest in and to any trademarks owned by Grantor, including, without limitation, the United States trademark registrations set forth on Schedule A, together with the goodwill associated therewith (the "Trademarks");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office ("PTO") on November 1, 2013 at Reel/Frame 5144/0068, July 1, 2015 at Reel/Frame 5567/0314, and December 28, 2015, at 5696/0736; and

WHEREAS, Grantor has now satisfied all of its outstanding indebtedness to Grantee.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreements, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
