**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT AND
RELATED AMENDMENTS**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT AND RELATED AMENDMENTS** (this "Termination"), dated as of February 28, 2020, is made by **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company, as agent ("Secured Party"), in favor of the Grantors listed on the signature pages of the Trademark Security Agreement (as defined below) (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of September 29, 2010 (as amended, restated, supplemented, or modified from time to time, the "Trademark Security Agreement"; capitalized terms used herein without definition shall have the meanings ascribed thereto in the Trademark Security Agreement), by and among Secured Party and Grantors, Grantors have granted a security interest to Secured Party in Grantors' entire right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral (as defined in the Trademark Security Agreement, Second Trademark Security Agreement and including Additional Trademark Collateral as defined in the First Amendment and Second Amendment) (the "Security Interest");

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (the "USPTO") on or about September 29, 2010 at Reel 004286, Frame 0708;

WHEREAS, pursuant to that certain Amendment Number One to Trademark Security Agreement dated as of September 30, 2013, made by Grantor in favor of Agent (the "First Amendment"), which was recorded in the records of the USPTO on or about September 30, 2013 at Reel 5120, Frame 0862, the Trademark Security Agreement was amended;

WHEREAS, pursuant to that certain Amendment Number Two to Trademark Security Agreement dated as of August 15, 2016, made by Grantor in favor of Agent (the "Second Amendment"), which was recorded in the records of the USPTO on or about August 15, 2016 at Reel 5855, Frame 0469, the Trademark Security Agreement was further amended;

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 28, 2017, made by Grantor in favor of Agent (the "Second Trademark Security Agreement"), which was recorded in the records of the USPTO on or about September 28, 2017 at Reel 6163, Frame 0303, the Trademark Security Agreement was further amended; and

WHEREAS, Secured Party has agreed to terminate and release its Security Interest in all of the Trademark Collateral, including those identified on Schedule A attached hereto.

NOW, THEREFORE, for valuable consideration, Secured Party hereby terminates, discharges, cancels and releases the Trademark Security Agreement, the First Amendment, the Second Amendment, the Second Trademark Security Agreement, and all mortgages, liens, collateral assignments, pledges and Security Interest granted to Secured Party in the Trademark Collateral.

Secured Party hereby reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in, to and under the Trademark Collateral.

Secured Party agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.


