TRADEMARK ASSIGNMENT

The terms of the Purchase Agreement, including the representations, warranties, covenants, agreements, indemnities, and limitations therein are not superseded by this Assignment, but remain in full force and effect to the full extent provided in the Purchase Agreement. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms of this Assignment, the terms of the Purchase Agreement are to govern.

Assignor covenants that, upon the reasonable request of Assignee, it will, at Assignee's sole cost and expense, execute all documents and take all such further action that is reasonably necessary to enable Assignee to obtain, maintain and enforce its rights and interest in and to the Trademarks.

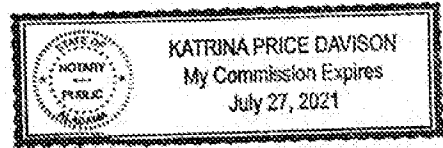
