10. This Certificate of Conversion may be signed in two or more counterparts, each of which shall be deemed an original, and all of which shall be deemed one instrument.

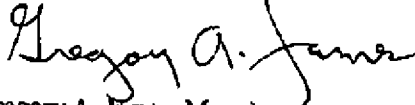
