WITNESSETH:



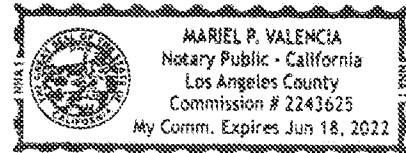
