This Declaration is being submitted in accordance with TMEP § 503.06(c) to identify the correct owner in view of two improper recordings.


I, Coby T. Page, do hereby say under penalty of perjury:

1. I am the Assistant General Counsel of Knight-Swift Transportation Holdings Inc.. I have firsthand knowledge of the facts relating to U.S. Registration No. 3,611,862 for THE CLEAN FLEET (the "Registration").
2. The correct and current owner of the Registration is **Swift Transportation Co., LLC**, a Delaware limited liability company, which became the named owner of the Registration by virtue of a name change from Swift Transportation Co., Inc. to Swift Transportation Co., LLC, which was recorded with the U.S. Patent and Trademark Office ("USPTO") on March 25, 2010 on at **Reel/Frame 4173/0886**, and this document is the correct and proper document.
3. Subsequently, there have been two documents that should not have been recorded.
4. The first document that should not have been recorded was a change of name from **Swift Transportation Company**, a Delaware corporation, to **Knight-Swift Transportation Holdings Inc.**, a Delaware corporation, which was recorded with the USPTO on March 14, 2019 at **Reel/Frame 6591/0546**.
5. The second document that should not have been recorded was a corrective assignment filed to correct the misspelling of "Transporation" for receiving party **Knight-Swift Transportation Holdings Inc.** in the previously filed change of name, where such corrective assignment was recorded on April 16, 2019 at

**Reel/Frame 6619/0262.** This second document should not have been filed simply because the change of name in paragraph 4 above should never have been filed.

6. Both the change of name and the corrective assignment should never have been filed because **Swift Transportation Co., LLC's** ownership of the Registration remained unaffected by the **Swift Transportation Company/Knight-Swift Transportation Holdings, Inc.** change of name event. Neither **Swift Transportation Company** nor **Knight-Swift Transportation Holdings Inc.** has owned this Registration at any time since **Swift Transportation Co., LLC** became owner.
7. Therefore, **Swift Transportation Co., LLC**, as reflected in the March 25, 2010 recordation document, continues to be the proper and rightful owner of the Registration.
8. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful, false statements may jeopardize the validity of the application or any patent issued thereon.
