
1. They are the **president** and the **secretary**, respectively, of InterHealth Nutraceuticals Incorporated, a California corporation.

The name of the corporation is Lonza Consumer Health Inc.

4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporation Code. The total number of outstanding shares of Common Stock of the corporation is 1,000 and the total number of outstanding shares of Series A Preferred Stock is zero. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
5. The future effective date of the foregoing amendment of Articles of Incorporation shall be March 1, 2020.
