**TERMINATION AND RELEASE OF
FIRST LIEN TRADEMARK SECURITY AGREEMENT**

This Termination and Release of First Lien Trademark Security Agreement (“Trademark Release”) is made as of March 4, 2020, by **TRUIST BANK** (successor by merger to SunTrust Bank), a North Carolina banking corporation (the “Collateral Agent”) in favor of **GOVOLUTION, LLC**, a Delaware limited liability company, **FIRST AMERICAN PAYMENT SYSTEMS, L.P.**, a Texas limited partnership, **CERTIFIED PAYMENT PROCESSING, L.P.**, a Texas limited partnership, **ELIOT MANAGEMENT GROUP, LLC**, Utah limited liability company, **GOEMERCHANT, LLC**, a Delaware limited liability company, **IATS, LLC**, a Delaware limited liability company, **ISTPAYGATEWAY, LLC**, a Delaware limited liability company, and **FITECH PAYMENTS, LLC**, a Delaware limited liability company (each, a “Grantor” and collectively, the “Grantors”).

W I T N E S S E T H:

WHEREAS, the Grantors entered into a certain first lien trademark security agreement dated January 6, 2017 (the “Trademark Security Agreement”) with the Collateral Agent, notice of which was recorded on January 6, 2017 at the United States Patent and Trademark Office at Reel 5960, Frame 0580.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a security interest (the “Security Interest”) in favor of the Collateral Agent, in all of each such Grantor’s right, title and interest in, to and under the Trademark Collateral, including the trademarks listed in **Schedule A**.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantors, and assigns, transfers and conveys to the Grantors the Security Interest in such Trademark Collateral.
