## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Agreement”) dated as of December 31, 2019, from Abacus Finance Group, LLC, in its capacity as administrative agent for the Lenders (the “Administrative Agent”), in favor of TriStar Global Energy Solutions, Inc., a Texas corporation (“Borrower”), United Laboratories International, LLC, a Delaware limited liability company (“ULI”), Tristar Petroserv, Inc., a Texas corporation (“Petroserv”) and Global Vapor Control, Inc., a Texas corporation, (“Global”, and together with Borrower, Petroserv, and ULI, each, a “Grantor”, and collectively, the “Grantors”).

### WITNESSETH:

WHEREAS, in connection with the Trademark Security Agreement, dated as of December 31, 2014 (the “Trademark Security Agreement”), the Administrative Agent was granted a security interest in all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement) from the Grantors (all capitalized terms used herein, but not otherwise defined herein, shall have the meanings set forth or referenced in the Trademark Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the “USPTO”) on January 5, 2015 at Reel 5433, Frame 0943/0953; and


WHEREAS, the Administrative Agent now wishes to release its liens on, and security interests in, the Trademark Collateral pertaining to Petroserv and Global (the “Released Grantors”) in the Trademark Security Agreement, including, without limitation, the trademarks as set forth on Schedule A attached hereto (the “Released Collateral”). Nothing contained herein shall be a release of any Trademark Collateral of the Borrower or ULI and the Trademark Security Agreement shall remain in full force and effect with respect to the Trademark Collateral of Borrower and ULI.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges all of its security interest in the Released Collateral, including any associated goodwill or common law rights, and reassigns any and all right, title and interest that it may have in or to the Released Collateral and associated goodwill and common law rights to each respective Released Grantor from whom such Released Collateral was collaterally assigned to the Administrative Agent pursuant to the Trademark Security Agreement.
2. Recordation. The Released Grantors or their authorized agent is authorized to record this Agreement with the USPTO.
3. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of New York.
4. Further Assurances. The Administrative Agent shall take all further actions, and provide to the Released Grantors and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Released Grantors, and at Released Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
