and all other violations in law or equity concerning the Trademarks;





- (2) GAMESYS SPAIN PLC (registered in Gibraltar with number C91180) whose registered office is at Capital Business Centre, Level 1, Entrance A, Triq taz-Zwejt, San Gwann, SGN 3000, Malta ("Gem Spain");
- (3) GAMESYS (GIBRALTAR) LIMITED (registered in Gibraltar with number 103854) whose registered office is at 57/63 Line Wall Road, Gibraltar GX11 1AA ("Gem Gibraltar");
- (4) ENTERTAINING PLAY LIMITED (registered in Gibraltar with number 101075) whose registered office is at 57/63 Line Wall Road, Gibraltar GX11 1AA ("EPL");

- (8) ROXOR GAMING (GIBRALTAR) LIMITED (registered in Gibraltar with number 117092) whose registered office is at 57/63 Line Wall Road, Gibraltar GX11 1AA ("RF Gibraltar");
- (9) ROXOR GAMING (MALTA) LIMITED (registered in Malta with number C80861) whose registered office is at Capital Business Centre, Entrance A, Level 1, Taz-Zwejt Street, San Gwann SGN 3000 ("RF Malta"); (each an "Assignee").

BACKGROUND

- (A) Pursuant to a Business Transfer Deed between the parties on or around the date of this Deed, an Assignee is purchasing certain assets of an Assignor.
- (B) Each Assignor is the proprietor of certain intellectual property rights as set out in the schedule to this Deed.
- (C) Each Assignor has agreed to assign the intellectual property rights for which it is listed as owner in the schedule to this Deed to an Assignee on the terms set out in this Deed.

IT IS AGREED AS FOLLOWS:

1. DEFINITIONS AND INTERPRETATION

"Assigned Rights" means the Registered IP Rights and the Intellectual Property Rights embodied in those Registered IP Rights.

"Intellectual Property Rights" means patents, rights to inventions, utility models, copyright and related rights, trade marks, business names and domain names, rights in get-up, goodwill and the right to sue for passing off, rights in designs, registered designs, database rights, rights

to use, and protect the confidentiality of, confidential information (including know-how) and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection whether known now or unknown, which subsist or will subsist now or in the future in any part of the world.

“Registered IP Rights” means the registered intellectual property rights owned by each Assignor as listed at Schedule 1 to this Deed.

- 1.1 Clause, Schedule and paragraph headings shall not affect the interpretation of this Deed.
- 1.2 The Schedules form part of this Deed and shall have effect as if set out in full in the body of this Deed. Any reference to this Deed includes the Schedules.
- 1.3 References to clauses and Schedules are to the clauses and Schedules of this Deed.
- 1.4 Unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular.
- 1.5 This Deed shall be binding on, and inure to the benefit of, the parties to this Deed and their respective personal representatives, successors and permitted assigns, and references to any party shall include that party's personal representatives, successors and permitted assigns.

## 2. ASSIGNMENT

- 2.1 Under this Deed:
  - 2.1.1 Gem hereby assigns to RF UK absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights.
  - 2.1.2 Gem Spain hereby assigns to RF Gibraltar absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights.
  - 2.1.3 Gem Gibraltar hereby assigns to RF Gibraltar absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights.
  - 2.1.4 EPL hereby assigns to RF Gibraltar absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights.
  - 2.1.5 LSL hereby assigns to RF Gibraltar absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights.
  - 2.1.6 PPL hereby assigns to RF Gibraltar absolutely with full title guarantee all its right, title and interest in and to the Assigned Rights.
- 2.2 The assignments at clause 2.1, shall include to the extent owned by each Assignor:
  - 2.2.1 all statutory and common law rights attaching to the Assigned Rights;
  - 2.2.2 the right to make new applications in respect of all or any of the Assigned Rights anywhere in the world;
  - 2.2.3 the absolute entitlement to any registrations granted pursuant to any of the applications comprised in the Assigned Rights; and
  - 2.2.4 the right to bring, make, oppose, defend, appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or

any other cause of action (including passing off) arising from ownership, of any of the Assigned Rights whether occurring before, on or after the date of this Deed.

### 3. FURTHER ASSURANCE

3.1 Each Assignor shall, at the relevant Assignee's cost, perform (or procure the performance of) all further acts and things, and execute and deliver (or procure the execution or delivery of) all further documents, required by law or which an Assignee reasonably requests, to vest in such Assignee the full benefit of the right, title and interest assigned to such Assignee under this Deed, including:

3.1.1 recordal of such Assignee as proprietor or applicant of the Assigned Rights; and

3.1.2 (subject to an Assignee indemnifying the relevant Assignor to its reasonable satisfaction against any claim, liability, costs (including adverse costs or orders for security for costs), expenses, damages or losses which may be incurred), assisting an Assignee in obtaining, defending and enforcing the Assigned Rights, and assisting with any other proceedings which may be brought by or against such Assignee against or by any third party relating to the Assigned Rights.

### 4. NOTICES

4.1 Any notice given under this Deed shall be in writing and served by hand, prepaid first class recorded delivery (including special delivery) or first class registered post or prepaid international recorded airmail ("Posted Notice") to the relevant addressee at the address referred to on page one (1) of this Deed or such other address as the relevant Party may designate to the other in writing from time to time. Any such notice shall be deemed to have been served at the time of delivery. Notice given under this Deed may also be validly served if sent by email to the relevant email address for notices as set out in this Deed (which shall be [Michael.Mee@anzogroup.com](mailto:Michael.Mee@anzogroup.com) for Assignees and [David.Carter@gamesys.co.uk](mailto:David.Carter@gamesys.co.uk) copied to [Lee.Fenton@gamesys.co.uk](mailto:Lee.Fenton@gamesys.co.uk) for Assignors or such other email address as a Party may designate to the other in writing from time to time), provided that if such notice relates to a breach of this Deed, a claim under the indemnities or termination of this Deed, a Posted Notice is also sent to the relevant Party. Any such notice sent by email shall be deemed to have been served at the time of delivery of such email or where a Posted Notice is also required, at the time of delivery of the associated Posted Notice.

4.2 For the avoidance of doubt, the Parties agree that the provisions of this Clause 4 shall not apply in relation to the service of any process in any legal action or proceedings arising out of or in connection with this Deed or the legal relationships established by this Deed.

### 5. GENERAL

5.1 Except as otherwise expressly provided in this Deed, each party will pay its own costs and expenses incurred in relation to the negotiation, preparation and implementation of this Deed and the documents referred to in it.


5.2 Only a party to this Deed has a right under the Contracts (Rights of Third Parties) Act 1999 to rely on or enforce any term of it. The parties may rescind, amend or vary any term of this Deed without the consent of any third party.

5.3 A failure or delay in exercising a right or remedy provided by this Deed or by law does not constitute a waiver of that right or remedy or of other rights or remedies. No single or partial exercise of any right or remedy provided under this Deed will prevent or restrict the further exercise of that or any other right or remedy.


- 5.4 A waiver of a breach of, or of a default under, this Deed does not constitute a waiver of any other breach or default of this Deed.
- 5.5 The parties may execute this Deed in any number of copies and on separate copies. Each such executed copy will be an original and all such executed copies together form one Deed.
- 5.6 This Deed (together with the documents referred to in it) constitutes the entire agreement between the parties with respect to the matters dealt with in it and supersedes any previous agreement between the parties in relation to them. Each Assignee acknowledges that no provisions are to be regarded as implied into this Deed, save for those implied by law and which are not lawfully capable of being excluded. All implied provisions lawfully capable of being excluded are excluded for all purposes. Nothing in this clause 5.6 shall limit any liability of any Assignor for fraud.
- 5.7 If any provision of this Deed is found to be invalid, illegal or unenforceable in any jurisdiction but would be valid, legal and enforceable if some part of the provision were modified or deleted, the provision will be modified or deleted to the minimum extent necessary to make it valid, legal and enforceable and to achieve to the greatest extent possible the intended effect in the relevant jurisdiction but will continue to apply without any modification in all other relevant jurisdictions. To the extent that it is not possible so to modify or delete the relevant provision, then it will be severed from this Deed insofar as it relates to that jurisdiction only and that invalidity, illegality or unenforceability will not affect the other provisions of this Deed or the relevant provision in any other jurisdiction, which will remain in full effect.
