TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement ("Agreement") is entered into on March 4, 2020 (the "Effective Date") by and between **Russell G. Weiner** ("**Assignor**"), an individual, and **Rockstar, Inc.** ("**Assignee**"), a Nevada corporation.

1. Transfer of Assigned Marks. Assignor hereby transfers and assigns to Assignee, and Assignee hereby accepts, all of Assignor's existing right, title, and interest in and to the Trademarks, including, without limitation, the specific trademark application and registration identified in Exhibit A attached hereto and all of Assignor's worldwide rights in and to the Trademarks including rights of registration and common law rights, together with all of the goodwill associated therewith.

2. Trademark Ownership; Prosecution of Infringements; Cooperation. Assignor acknowledges that Assignee is the sole and exclusive owner of, and has the sole and exclusive right to use, register, and enforce the Trademarks as currently used or intended to be used on the goods and services described in the registrations. The parties agree to execute any documents in any jurisdiction as may be reasonably required to accomplish the transfer and assignment of all right, title, interest and goodwill that Assignor has in the Trademarks to Assignee.

3. Successor and Assigns. The parties acknowledge that they are acting on behalf of, and that this Agreement shall bind and benefit, the parties and their respective heirs, representatives, successors, assigns, parents, subsidiaries, affiliates, and licensees throughout the world.


