RELEASE OF SECURITY INTEREST IN SERVICE MARKS

This **RELEASE OF SECURITY INTEREST IN SERVICE MARKS** (this "Release"), dated as of March 4, 2020, is made by RESOLUTE CAPITAL PARTNERS FUND III, L.P., formerly known as Tenth Street Fund III, L.P. ("Lender"), in favor of FLORIDA AUTISM CENTER, LLC, a Florida limited liability company ("Debtor"). Capitalized terms not defined herein have the meanings assigned to them in the Loan Agreement (as defined below).

WHEREAS, Debtor, Lender and the other parties thereto entered into that Loan Agreement, dated as of August 21, 2015 (the "Loan Agreement") and that Security Agreement dated as of August 21, 2015 (the "Security Agreement");

WHEREAS, pursuant to the Loan Agreement and the Security Agreement, Debtor executed and delivered to Lender that Service Marks Security Agreement, dated as of August 21, 2015 (the "Service Marks Security Agreement"), for recordation with the United States Patent and Trademark Office (the "USPTO");

WHEREAS, the Service Marks Security Agreement was recorded with the USPTO on August 25, 2015 at Reel/Frame 5608/0581;

WHEREAS, pursuant to the terms and conditions of the Security Agreement and the Service Marks Security Agreement, Debtor granted to Lender a security interest in the service mark applications described in Schedule A hereto and in any service marks arising therefrom (the "Service Mark Collateral"); and

WHEREAS, Lender has agreed to execute and deliver this Release to release of its security interest in the Service Marks Collateral and to evidence the same for recordation with the USPTO.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, including the satisfaction of all Obligations secured by the Service Marks Collateral, the receipt and sufficiency of which are hereby acknowledged, Lender hereby agrees as follows:

Lender hereby (i) terminates, releases and discharges its security interest in the Service Marks Collateral, (ii) reassigns and retransfers to Debtor any and all right, title and interest Lender may have in or to the Service Marks Collateral, and (iii) terminates the Service Marks Security Agreement.

Lender hereby (i) authorizes Debtor or any of its authorized designees to file this Release with the USPTO, and (ii) further requests that the USPTO record this Release.
