RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of February 24, 2020 ("Effective Date") by PNC Bank, National Association, as Agent (in such capacity, together with its successors in such capacity, the "Grantee"), in favor of American Accessories, Inc., a Delaware corporation (the "Grantor").

WHEREAS, pursuant to the Revolving Credit, Term Loan and Security Agreement, dated May 7, 2015 (as amended and in effect from time to time, the "Credit Agreement"), by and among the Grantor, the Lenders (as defined therein) and the Grantee, and the Trademark Security Agreement, dated May 7, 2015, executed by the Grantor in favor of the Grantee (the "Assignment"), which Assignment was recorded at Reel 5548, Frame 0490, the Grantee was granted a security interest in all of the Grantor's right, title, and interest in and to certain trademarks (the "Collateral"), including the trademark set forth on Schedule A attached hereto (the "Trademark Collateral"); and

WHEREAS, pursuant to the Credit Agreement and the Assignment, the Grantee duly recorded the security interest of the Lenders in the Collateral with the United States Patent and Trademark Office ("USPTO"); and


WHEREAS, in connection with the execution of an Asset Purchase Agreement, pursuant to which the Grantor is selling the Trademark Collateral, the Grantor has requested that the Grantee release the Lenders' security interest in the Trademark Collateral, and the Grantee has agreed to do so.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee, on behalf of the Lenders, hereby: (a) fully releases the Grantor and its successors and assigns from any and all obligations set forth in the Credit Agreement and the Assignment; (b) fully releases and discharges the Trademark Collateral from the effect and operation of the Credit Agreement and the Assignment; (c) terminates the Lenders' security interest in the Trademark Collateral granted pursuant to the Credit Agreement and the Assignment; and (d) acknowledges that all such interests are hereby reassigned to the Grantor. The Grantee hereby grants the Grantor the right to file all documents with the USPTO as may be necessary to accomplish the foregoing on behalf of the Grantee.
