ARTICLES OF INCORPORATION  
WITH STATEMENT OF CONVERSION  
OF  
MOTO ENTERTAINMENT INC.

ARTICLE I.

The name of the corporation is: Moto Entertainment Inc.

ARTICLE II.

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

ARTICLE III.

This corporation is authorized to issue two classes of shares designated "Common Stock" and "Preferred Stock". The total number of shares that the corporation is authorized to issue is One Thousand and Two (1,002) shares. One Thousand (1,000) shares shall be Common Stock, without par value, and Two (2) shares shall be Preferred Stock, without par value. The board of directors of the corporation is granted the power to designate the rights, preferences, privileges, and restrictions for the respective wholly unissued classes of shares.

ARTICLE IV.

(Statement of Conversion)

The name of the converting California limited liability company is Moto Entertainment LLC. The limited liability company's California Secretary of State file number is 200932110013. The principal terms of the plan of conversion were approved by a vote of the members, which equaled or exceeded the vote required under California Corporations Code section 17710.03. There is one class of members entitled to vote and the percentage vote required is a majority in interest of the members. The limited liability company is converting into a California stock corporation.
