Banner Bank will be the surviving bank in the Merger.

1. The Bank Merger Agreement is set forth on the attached Exhibit A (the "Plan of Merger") and made part of these Articles of Merger.
2. The Plan of Merger was duly approved by the directors and shareholders of AltaPacific Bank and Banner Bank pursuant to Section 30A.49.050 of the RCW and the relevant provisions of the California Corporations Code.
3. The Merger will become effective at 12:02 a.m. Pacific Time on November 1, 2019.

BANK MERGER AGREEMENT

This Bank Merger Agreement ("Agreement"), dated as of November 1, 2019, is made by and between Banner Bank and AltaPacific Bank.

RECITALS

A. Banner Bank, a wholly owned subsidiary of Banner Corporation ("Banner"), is a Washington state-chartered commercial bank. Banner Bank has authorized capital stock of (i) 5,000,000 shares of common stock with a par value of \$1.00 per share, of which 1,000 shares are issued and outstanding and (ii) 1,000,000 shares of preferred stock with a par value of \$1.00 per share, none of which are issued and outstanding. A list of Banner Bank's office locations is attached as Exhibit A.

B. AltaPacific Bank, a wholly owned subsidiary of AltaPacific Bancorp ("AltaPacific"), is a California banking corporation. AltaPacific Bank has authorized capital stock of (i) 40,000,000 shares of voting common stock without par value, of which 100 shares are issued and outstanding and (ii) 10,000,000 shares of preferred stock with no par value, none of which are issued and outstanding. A list of AltaPacific Bank's office locations is attached as Exhibit B.

C. Banner and AltaPacific entered into an Agreement and Plan of Merger dated as of July 24, 2019 (the "Merger Agreement"), pursuant to which, subject to the terms and conditions set forth therein, AltaPacific will merge with and into Banner, with Banner as the surviving corporation (the "Holding Company Merger"). Immediately following the Holding Company Merger, subject to the terms and conditions set forth herein, AltaPacific Bank will merge with and into Banner Bank, with Banner Bank as the resulting entity.

D. The Boards of Directors of Banner Bank and AltaPacific Bank have each adopted and approved this Agreement and authorized its execution and delivery.

AGREEMENT

1. MERGER TERMS

1.1 Merger. Subject to the terms and conditions of this Agreement, AltaPacific Bank will merge with and into Banner Bank (the "Merger"), and after the Merger, Banner Bank will be the surviving bank (the "Resulting Bank").

1.2 Closing. Unless the parties agree otherwise, the closing of the Merger ("Closing") will take place immediately following the closing of the Holding Company Merger (the "Effective Time") subject to approval of the Merger in accordance with Sections 2 and 3 and expiration of all applicable waiting periods. For the avoidance of doubt, the occurrence of the Holding Company Merger shall be a condition to the obligation of each of the parties hereto to effect the Closing, and neither party shall have any obligation to effect the Closing and consummate the Merger unless the Holding Company Merger has occurred in accordance with the terms of the Merger Agreement. If the Merger Agreement is terminated in accordance with its terms prior to the closing of the Holding Company Merger, this Agreement shall automatically

terminate and be void, and the parties will be relieved of their obligations and responsibilities under this Agreement.

1.3 Transaction. At the Effective Time, the following will occur:

(a) AltaPacific Bank Shares. All shares of AltaPacific Bank capital stock issued and outstanding immediately before the Effective Time will be canceled and will cease to exist, and no consideration will be delivered in exchange therefor.

(b) Banner Bank Shares. All shares of Banner Bank capital stock issued and outstanding immediately before the Effective Time will continue as issued and outstanding shares of the Resulting Bank.

(c) Dissenting Shares. No shares of the Resulting Bank will need to be disposed as the result of dissenting shareholders, since the Merger will not be consummated if the sole shareholder of either Banner Bank or AltaPacific Bank declines to approve this Agreement.

1.4 Resulting Bank. The Resulting Bank's name will be "Banner Bank." Banner Bank's charter, articles of incorporation and bylaws will become the Resulting Bank's charter, articles of incorporation and bylaws and are not being amended as part of the Merger. Banner Bank's principal office will become the Resulting Bank's principal office, and all other offices of Banner Bank and AltaPacific Bank will become offices of the Resulting Bank. The Resulting Bank's principal office and other office locations are set forth on Exhibit C, attached hereto and incorporated by this reference. The Resulting Bank will be a wholly-owned subsidiary of Banner, with the same number of issued and outstanding shares and the same par value as the issued and outstanding shares of Banner Bank immediately before the Effective Time.

1.5 Resulting Bank Directors. The members of the Resulting Bank's Board of Directors (collectively, the "Resulting Directors"), effective at the Effective Time, will include the members of the Board of Directors of Banner Bank as constituted immediately prior to the Effective Time. The Resulting Directors' names and mailing addresses are set forth on Exhibit D, attached hereto and incorporated by this reference.

1.6 Resulting Bank Officers. The names and mailing addresses of the officers of the Resulting Bank are listed on Exhibit D, attached hereto and incorporated by this reference.

2. SHAREHOLDER APPROVAL.

The Merger and this Agreement are subject to approval by Banner, as Banner Bank's sole shareholder, and by AltaPacific, as AltaPacific Bank's sole shareholder. If either Banner or AltaPacific does not approve the Merger and this Agreement, this Agreement is void, and the parties are relieved of their obligations and responsibilities under this Agreement.

3. REGULATORY APPROVALS.

The Merger and this Agreement are subject to approval (or waiver, if applicable) by the Federal Deposit Insurance Corporation, the Washington State Department of Financial Institutions, Division of Banks, and all other regulatory agencies having jurisdiction with respect

to the Merger. If these agencies do not approve the Merger and this Agreement, this Agreement is void, and the parties are relieved of their obligations and responsibilities under this Agreement.

4. MISCELLANEOUS PROVISIONS.

4.1 Binding Effect. This Agreement is binding and inures to the benefit of the parties and their respective successors and assigns.

4.2 Assignment. No party may assign this Agreement or any rights under this Agreement, unless the other party consents in writing to the assignment.

4.3 Amendment and Waiver. Except as this Agreement otherwise expressly provides, it contains the parties' entire understanding. No modification or amendment of its terms or conditions is effective unless in writing and signed by the parties.

4.4 Section Headings. The section headings included in this Agreement are for reference and convenience only and are not a substantive part of this Agreement.

4.5 Counterparts. This Agreement may be executed in one or more counterparts. Each of these counterparts will be deemed an original, and all counterparts taken together constitute one and the same document.

4.6 Governing Law. The parties intend this Agreement to be governed by the laws of the State of Washington, except to the extent Federal law or California banking law may govern certain matters.

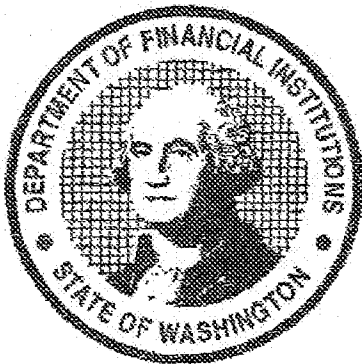
