GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

March 5, 2020

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, LINE-X LLC, a Delaware limited liability company with offices at 301 James Record Rd. Suite 250 Huntsville, AL 35824, and ULTIMATE LININGS, LLC, a Texas limited liability company with offices at 10301 Round Up Lane, Houston, TX 77064 and GROUND EFFECTS LTD., an Ontario corporation with offices at 4505 Rhodes Drive, Windsor, ON N8W 5R8 (each a “Grantor” and together the “Grantors”), hereby grant to WELLS FARGO BANK, NATIONAL ASSOCIATION (the “Grantee”), a continuing security interest in (i) all of each Grantor’s right, title and interest in, to and under all of such Grantor’s United States trademarks, trademark registrations and trademark applications (the “Marks”), including those set forth on Schedule A attached hereto, (ii) all proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, (iv) all income, fees, royalties, damages, claims and payments now or hereafter due and/or payable thereunder and with respect thereto including, without limitation, damages and payments for past, present or future infringements thereof, (v) any and all rights corresponding thereto throughout the world, and (vi) any and all rights to sue for past, present or future infringements thereof. Provided, however, that no “intent-to-use” application for registration of a Trademark (as defined in the Security Agreement) filed pursuant to Section 1(b) of the Lanham Act, 15 U.S.C. § 1051, shall be considered a Mark hereunder prior to the filing of a “Statement of Use” pursuant to Section 1(d) of the Lanham Act or an “Amendment to Allege Use” pursuant to Section 1(c) of the Lanham Act with respect thereto, or if filed, has not been deemed in conformity with 15 U.S.C. §1051(c) or (d), solely to the extent, if any, that, and solely during the period, if any, in which, the grant of a security interest therein would impair the validity or enforceability of any registration that issues from such intent-to-use application under applicable federal law

THIS GRANT is made to secure the satisfactory performance and payment of all the Secured Obligations of the Grantor, as such term is defined in the U.S. ABL Security Agreement by, among the

Grantors, the Grantee, and the other Guarantors (as such term is defined therein) party thereto, dated as of the date hereof (as amended, modified, restated and/or supplemented from time to time, the “Security Agreement”). The rights and remedies of the Grantee with respect to the security interest granted herein are as set forth in the Security Agreement, all terms and provisions of which are incorporated herein by reference. 


