ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, The Matchless Metal Polish Company, having an address 840 West 49th Place, Chicago, IL 60609, an Illinois corporation (“Assignor”), (i) owns all right title and interest in and to the trademarks and registrations listed on Schedule A, hereto; (ii) owns certain rights in and to the trademarks, listed on Schedule B, hereto and (iii) owns all right, title and interest in and to the domain names and registrations listed on Schedule C, hereto (collectively hereinafter the “Trademark Rights and Domain Names”) and the goodwill of the business in connection with which the Trademark Rights and Domain Names are used and which is symbolized thereby; and

WHEREAS, Osborn, LLC, organized and existing under the laws of the State of Delaware, with its principal place of business at 833 East Michigan Street, Suite 900, Milwaukee, WI 53202 (“Assignee”), desires to acquire the Trademark Rights and Domain Names and the goodwill of the business symbolized thereby in accordance with that certain Asset Purchase Agreement dated as of the date hereof, among Assignor, Assignee and Frank Ungari, the sole shareholder of Assignor (the “Purchase Agreement”).

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein, Assignor and Assign hereby agree as follows:

1. Assignor does hereby assign unto Assignee all of Assignor’s rights, title, and interest in and to the Trademark Rights and Domain Names, together with the goodwill of the business in connection with which the Trademark Rights and Domain Names are used along with the right to recover for damages and profits for past, present, or future infringements thereof.
2. Assignor agrees to execute and deliver at the request of the Assignee, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor’s rights, title, and interest in and to the Trademark Rights and Domain Names to the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment or support any claims for infringement of the Trademark Rights and Domain Names, to the extent such evidence is in the possession, custody or control of Assignor. Except to the extent provided otherwise in the Purchase Agreement, all fees and expenses relating to recording the assignments and to supporting any claims of infringement shall be paid by Assignee.
3. Where appropriate, Assignor and Assignee each authorizes and requests (i) the Commissioner of Trademarks of the United States Patent and Trademark Office and the Canadian Trademark Office, whose duty it is to register trademarks and to record Assignee as the assignee and owner of the Trademark Rights; and (ii) the issuing domain name registry to record Assignee as the assignee and owner of the Domain Names.


