TERMINATION AND RELEASE OF SECURITY INTEREST

This TERMINATION AND RELEASE OF SECURITY INTEREST is given by MADISON PACIFIC TRUST LIMITED, with an address at 18 Harcourt Road, 1720, Tower One, Admiralty Centre, Hong Kong, in its capacity as Security Agent pursuant to a Security Agreement, dated as of June 24, 2019, as amended to date (in such capacity, the "Security Agent"), to BLUE FOUNTAIN MEDIA INC., a New York corporation ("Grantor").

WHEREAS, Grantor has fully satisfied all of its obligations as set forth in the Security Agreement and performed all of its obligations to the Security Agent under the Security Agreement.

NOW, THEREFORE, to all whom it may concern, be it known that, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Security Agent does hereby terminate and release in full all liens and security interests created by and set forth in the Security Agreement granted by Grantor in favor of the Security Agent with respect to the Trademarks and the goodwill associated therewith.
