**TERMINATION AND RELEASE OF SECURITY INTEREST**

This TERMINATION AND RELEASE OF SECURITY INTEREST is given by MADISON PACIFIC TRUST LIMITED, with an address at 18 Harcourt Road, 1720, Tower One, Admiralty Centre, Hong Kong, in its capacity as Security Agent pursuant to a Security Agreement, dated as of June 24, 2019, as amended to date (in such capacity, the “**Security Agent**”), to PACTERA TECHNOLOGY INTERNATIONAL LTD., a Cayman Islands limited company (“**Grantor**”).

WHEREAS, Grantor executed and delivered to the Security Agent a Trademark Security Agreement, dated as of June 24, 2019, granting to Security Agent a security interest in certain trademark collateral of Grantor and the goodwill associated therewith, which Security Agreement was recorded with the United States Patent & Trademark Office on June 25, 2019 in Reel 6677 beginning at Frame 0803 (the “**Security Agreement**”);

WHEREAS, said certain trademark collateral includes, *inter alia*, the trademarks embodied in the U.S. Trademark Registrations set forth on Schedule A (collectively, the “**Trademarks**”); and

WHEREAS, Grantor has fully satisfied all of its obligations as set forth in the Security Agreement and performed all of its obligations to the Security Agent under the Security Agreement.

NOW, THEREFORE, to all whom it may concern, be it known that, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Security Agent does hereby terminate and release in full all liens and security interests created by and set forth in the Security Agreement granted by Grantor in favor of the Security Agent with respect to the Trademarks and the goodwill associated therewith.
