RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to that certain Trademark Security Agreement, dated April 27, 2016, recorded in the United States Patent and Trademark Office at Reel 5779, Frame 0711 (the "April 2016 Trademark Security Agreement"), AVI-SPL, Inc., a Delaware corporation, Signal Perfection Ltd., a Maryland corporation, and Audio Visual Innovations, Inc., a Florida corporation, granted to Cerberus Business Finance, LLC, a Delaware limited liability company ("Releasor"), as collateral agent for itself and various other financial institutions, a security interest in all right, title and interest of AVI-SPL, Inc., Signal Perfection Ltd. and Audio Visual Innovations, Inc. in and to the Trademark Collateral, including the trademark registrations and applications listed on Schedule A attached hereto; and

WHEREAS, pursuant to that certain Trademark Security Agreement, dated November 30, 2016, recorded in the United States Patent and Trademark Office at Reel 5934, Frame 0950 (the "November 2016 Trademark Security Agreement"), Anderson Audio Visual, Inc., a California corporation, granted to Releasor, as collateral agent for itself and various other financial institutions, a security interest in all right, title and interest of Anderson Audio Visual, Inc. in and to the Trademark Collateral, including the trademark registrations and applications listed on Schedule B attached hereto; and

WHEREAS, AVI-SPL, Inc., Signal Perfection Ltd., Audio Visual Innovations, Inc. and Anderson Audio Visual, Inc. have requested, and Releasor wishes to provide, a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the trademark registrations and applications listed on Schedule A and Schedule B, attached hereto.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the April 2016 Trademark Security Agreement and the November 2016 Trademark Security Agreement.
2. Release of Security Interest. Releasor, without representation, warranty or recourse, hereby releases, relinquishes, terminates, cancels and discharges its continuing security interest in the Trademark Collateral, including without limitation, its continuing security interest in the trademark registrations and applications listed on Schedule A and Schedule B, attached hereto, and all goodwill of the business connected with the use of, and symbolized by, such Trademark Collateral.
