PERDUE FOODS LLC
(a Maryland limited liability company)

Pursuant to Title 8, Section 264(c) of the Delaware General Corporation Law (the "DGCL"), the undersigned limited liability company executed the following Certificate of Merger:

FIRST: The name of the surviving limited liability company is Perdue Foods LLC, a Maryland limited liability company (the "Surviving Company").

SECOND: The name of the corporation being merged with and into the Surviving Company is Pasturebird, Inc., which was incorporated under the laws of the State of Delaware (the "Merging Corporation").

THIRD: The Agreement and Plan of Merger among the Surviving Company and the Merging Corporation, dated as of November 12, 2019 (the "Agreement of Merger") setting forth the terms of the merger of the Merging Corporation with and into the Surviving Company (the "Merger"), has been approved, adopted, certified, executed and acknowledged by each of the Merging Corporation and the Surviving Company pursuant to Title 8, Section 264 of the DGCL.

FOURTH: The Merger shall be effective at 11:59 p.m., Eastern time, on November 26, 2019.

FIFTH: The executed Agreement of Merger is on file at the principal place of business of the Surviving Company, at 31149 Old Ocean City Road, Salisbury, Maryland 21804.

SIXTH: A copy of the Agreement of Merger will be furnished by the Surviving Company on request, without cost, to any member of the Surviving Company or any stockholder of the Merging Corporation.

SEVENTH: The Surviving Company agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of the Merging Corporation, as well as for enforcement of any obligation of the Surviving Company arising from this Merger, including any suit or other proceeding to enforce the rights of any stockholders as determined in appraisal proceedings pursuant to the provisions of Section 262 of the DGCL, and irrevocably appoints the Secretary of State of Delaware as its agent to accept service of process in any such suit or proceeding. The Secretary of State shall mail any such process to the Surviving Company at 31149 Old Ocean City Road, Salisbury, Maryland 21804.
