TRADEMARK ASSIGNMENT


WHEREAS, FanDuel Limited (“FDL”), a Scotland Limited Company, having a mailing address at c/o Shepherd and Wedderburn LLP, 1 Exchange Crescent, Conference Square, Edinburgh Scotland EH38UL, owns all right, title, and interest in and to United States trademark applications and registrations identified in the attached Exhibit A (hereinafter the “Marks”);

WHEREAS, FanDuel Group, Inc. (“FDG”), a Delaware corporation having a principal place of business at 300 Park Avenue South, 14th Floor, New York, NY 10010, is desirous of acquiring all of FDL’s right, title, and interest in and to the Mark.

NOW, THEREFORE, for the receipt of one (\$1) dollar and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, FDL, intending to be legally bound, does hereby assign, transfer, grant, sell, and set over to FDG: (a) FDL’s entire right, title, and interest in and to the Marks throughout the world, together with the goodwill of FDL’s business in connection with which the Marks is used; and (b) the full right to sue for past, present, or future infringement of the Marks, all of these rights to be held and enjoyed by FDG, its successors and assigns, as fully as the same would have been held and enjoyed by FDL. For the consideration aforesaid, FDL will, upon request, and at FDG’s sole expense and at no expense to FDL, execute additional lawful papers and generally do all other lawful acts reasonable and necessary to give effect to and to record this Assignment. FDL warrants and represents (a) that it owns the unencumbered and complete right, title, and interest to the Marks, (b) that it possesses the unencumbered right and authority to grant this Assignment, (c) that there are no prior licenses or assignments concerning the Marks, (d) that the Marks does not infringe the rights of any third party, (e) that no claims, demands, or lawsuits have been asserted concerning the Marks, (f) that the Marks have not been and are not currently being infringed by any third party, and (g) that FDL does not own or use, has not applied for, and will not use or apply for any other trademarks, service marks, or trade dress identical or similar to, or containing, the Marks.

IN WITNESS WHEREOF, FDL has caused this instrument to be signed by its duly authorized representative effective as of the 10th day of March, 2020.
