TRADEMARK ASSIGNMENT

This Trademark Assignment (this “**Assignment**”) is dated as of March 11, 2020 between Oregon Potato Company, a Washington corporation (“**Assignor**”), and PNW Veg. Co., LLC, a Washington limited liability company (“**Assignee**”).


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The above recitals are incorporated herein as if set forth at length below.
2. Assignor hereby assigns and transfers to Assignee all of Assignor’s right, title and interest throughout the world in and to the Marks and all common law rights and goodwill associated with the Marks.
3. The parties shall take all actions and execute all documents reasonably requested by the other party to give effect to the transactions contemplated by this Agreement.
4. Assignor authorizes and requests the United States Commissioner of Patents and Trademark and any other similar government authority to record Assignee as the assignee and owner of the Marks, and to issue any and all registrations thereon to Assignee as assignee of the entire right, title and interest in and to the same.
5. Assignee accepts the assignment and conveyance of the Marks.
6. This Agreement shall be governed by and construed in accordance with the internal laws of the state of Washington without giving effect to any choice or conflict of law provision or rule (whether of the state of Washington or any other jurisdiction).
7. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.






