PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

This **PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST** (this “*Partial Release*”) is granted as of March 13, 2020 by **VIRTUS GROUP, LP**, as administrative agent and collateral agent (the “*Administrative Agent*” or the “*Grantee*”), in favor of **TEKRA, LLC**, a Delaware limited liability company, and **TRIENT, LLC**, a Delaware limited liability company (each individually, a “*Grantor*”, and, collectively, the “*Grantors*”);

WHEREAS, the Grantors, among others, have executed and delivered a Trademark Security Agreement, dated as of dated September 30, 2019 and recorded on October 2, 2019 at Reel 6762, Frame 0035 (the “*Trademark Agreement*”), which was recorded with the United States Patent and Trademark Office (the “*USPTO*”); capitalized terms used herein and not defined herein shall have the meanings ascribed to them in the Trademark Agreement.

WHEREAS, pursuant to the Trademark Agreement, each Grantor has granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademarks set forth in Schedule A annexed hereto (the “*Specified Trademark Collateral*”); and

WHEREAS, each Grantor has requested that that the Grantee terminate, release and discharge fully its security interest in the Specified Trademark Collateral and to re-convey to the applicable Grantor any and all rights in and to the Specified Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby terminate, release and discharge, without any representation or warranty, any and all liens and security interests it may have in and to the Specified Trademark Collateral and releases all other rights it may have to the Specified Trademark Collateral under the Security Agreement and the Trademark Agreement.

The Grantee, to the extent granted in the Security Agreement or the Trademark Agreement, hereby assigns, grants and otherwise re-conveys to the applicable Grantor all of its right, title and interest in and to the Specified Trademark Collateral originally granted to the Grantee pursuant to the Security Agreement or Trademark Agreement.

The Grantee hereby authorizes and requests that the USPTO note and record this Partial Release.

Except for the release of Specified Trademark Collateral specifically identified on Schedule A attached hereto, all terms and provisions of the Trademark Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Trademark Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. **Any lien and/or security interest granted in any Trademarks pursuant to the Trademark Agreement shall remain unchanged and in full force and effect except as specifically released hereby and shall continue to secure the payment and performance of all of the Secured Obligations (as defined in the Security Agreement).**

THIS PARTIAL RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN
ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
