RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of March 13, 2020 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Administrative Agent") for the financial institutions which are from time to time parties to the Credit Agreement referred to in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, COMMISSION JUNCTION, INC., a Delaware corporation ("Grantor"), and certain other entities executed that certain Amended and Restated Intellectual Property Security Agreement, dated as of August 19, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Administrative Agent, pursuant to which the Grantor granted a security interest to the Administrative Agent in certain trademarks and other property of Grantor; and

WHEREAS, in connection with said Security Agreement, documentation was recorded with the United States Patent and Trademark Office at Reel 005093, Frame 0767 on August 19, 2013; and

WHEREAS, the Administrative Agent has agreed to release all its liens on the trademarks and trademark applications of the Grantor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Administrative Agent's right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
