## **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of March 13, 2020, and made by **TRUIST BANK** (as successor by merger to SunTrust Bank), as agent (the "Grantee"), to **YOUTH INSURANCE AGENCY, INC.**, a California Corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of January 31, 2019 by the Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to the Grantee for the benefit of the Secured Parties (as defined in the Security Agreement) in certain collateral, including the Trademark Collateral (as hereinafter defined), as security for the prompt and complete payment and performance of the Secured Obligations (as defined in the Security Agreement) of the Grantor;

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on February 1, 2019 at Reel/Frame 6547/0456;

WHEREAS, the Grantor has requested that Grantee release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Grantee's security interest in the Trademark Collateral; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its lien on and security interest in the Trademark Collateral and reassigns to Grantor all right, title and interest of Grantee in the Trademark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
