**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of March 12, 2020 by OWL ROCK CAPITAL CORPORATION, as Collateral Agent for the benefit of the Secured Parties (the "Collateral Agent") in favor of SINGLECARE SERVICES LLC, a Delaware limited liability company (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

**W I T N E S S E T H**

WHEREAS, the Grantor and the Collateral Agent entered into that certain Security Agreement dated as of February 15, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Collateral Agent that certain Trademark Security Agreement dated as of February 15, 2019 (the "Trademark Security Agreement") and recorded with the United States Patent and Trademark Office on February 15, 2019 at Reel/Frame No. 6565/0303, pursuant to which the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement);


WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
