TRADEMARK AND TRADE NAME ASSIGNMENT

This Trademark Assignment (this “**Assignment**”), dated as of March 10, 2020, is entered into between EMMIS QOZ BUSINESS, LLC, an Indiana limited liability company (“**Purchaser**”), and Lencore Acoustics Corporation, a New York corporation (“**Seller**”).

RECITALS

WHEREAS, Seller is the owner of the registered trademarks and U.S. Trademark Registrations set forth in Appendix A and the unregistered trademarks set forth in Appendix B (collectively, the “**Assigned Trademarks**”);

WHEREAS, Seller is the owner of the unregistered trade names set forth in Appendix C (collectively, the “**Assigned Trade Names**”);

WHEREAS Purchaser desires to acquire from Seller and Seller has agreed to assign and transfer unto Purchaser, all of Seller’s right, title and interest in and to the Assigned Trademarks and the Assigned Trade Names, together with all rights related thereto and with the goodwill of the business symbolized thereby.

NOW, THEREFORE, in consideration of the mutual covenants and agreements hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Seller hereby irrevocably assigns, transfers, grants and conveys to Purchaser, free and clear of all pledges, security interests, liens, charges, encumbrances, equities, claims, options or limitations of any kind, all of Seller’s worldwide right, title and interest in, to and under the Assigned Trademarks and the Assigned Trade Names, including all common law rights related thereto, together with the goodwill of the business associated therewith and which is symbolized thereby, including all rights to sue for infringement thereof, whether arising on, prior to or subsequent to the date of this Assignment, and any and all applications for registration, registrations, renewals and extensions thereof that currently exist, including the U.S. Trademark Registrations identified in Appendix A and all renewals thereof, or that may hereafter be secured under the laws of the United States and in any other jurisdiction, including any and all Convention and Treaty rights, such as rights of priority, the same to be held and enjoyed by Purchaser, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Seller had this Assignment not been made.

2. Seller shall cooperate with the Purchaser, and execute, acknowledge and deliver to Purchaser, at Purchaser’s reasonable request, any and all further documents, papers, affidavits, statements and/or other instruments, whether or not in paper or electronic form, to confirm Purchaser’s ownership of all rights pursuant to this Assignment.

3. Seller hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Assignment.

4. This Assignment may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

5. This Assignment shall be binding upon the successors and assigns of Seller and inure to the benefit of the successors and assigns of Purchaser.
