Deed of Assignment

Date: 01/23/2020

Parties:

(1) "The Assignor": Aquatrols Corporation of America of 1273 Imperial Way, Paulsboro NJ 08066, United States of America.

(2) "The Assignee": The Fairways Foundation of 1273 Imperial Way, Paulsboro NJ 08066, United States of America.

Recitals:

(A) The Assignor is the registered proprietor of the Trade Marks particulars of which are set out in Schedule 1 below and the applicant for registration of the Trade Marks particulars of which are set out in Schedule 2 below (collectively called "the Trade Marks").

(B) The Assignor has agreed to assign the Trade Marks to the Assignee together with the business pertaining to the Trade Marks, including all goodwill of the business in respect of which the Trade Marks are registered or registration has been sought as set out below.

Operative provisions:

1. IN pursuance of the said agreement and in consideration of the sum of USD 10 (the receipt of which is hereby acknowledged) the Assignor with full title guarantee HEREBY ASSIGNS unto the Assignee:

1.1. all of the Assignor's right and title to and interest in the Trade Marks and the full and exclusive benefit of each of them together with the goodwill of the business of the Assignor concerned in the goods and/or services in respect of which the Trade Marks are registered or applied for;

1.2. all of the rights of the Assignor to and in the Trade Marks and the right in respect

of the Trade Marks to apply to each of the national Trade Mark Offices of the Trade Marks to be registered as proprietor in that country; and

1.3. the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of the Trade Marks whether committed before or after the date of this Agreement

TO HOLD the same unto the Assignee absolutely.

2. The Assignor HEREBY COVENANTS with the Assignee that the Assignor will at the expense of the Assignee execute sign and do all such instruments applications documents acts and things as may reasonably be required by the Assignee to enable the Assignee or its nominee to enjoy the full benefit of the rights hereby assigned and to apply for and obtain registration of the Assignee as the registered proprietor of the Trade Marks.

3. The Assignee HEREBY AGREES to the terms of this Agreement.

4. This Agreement is governed by the law of the State of New Jersey in the United States of America, and is subject to the exclusive jurisdiction of the courts of the State of New Jersey in the United States of America.




