TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of March 16, 2020, and made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Collateral Agent (the "Grantee"), to CENTRAL SALT, L.L.C., a Missouri limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Grant of Security Interest in United States Marks dated as of November 18, 2016 by the Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Mark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on November 21, 2016 at Reel/Frame 5925/0832; and

WHEREAS, Grantor has requested that Grantee acknowledges the termination and release of the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Mark Collateral" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby acknowledges the termination of the Security Agreement as contemplated under Section 4 thereof and terminates, releases and discharges its lien on and security interest in and to the Mark Collateral and reassigns to Grantor any and all right, title and interest of Grantee in the Mark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
